**Art. 4º** Ficam revogadas as disposições em contrário, em especial a Portaria nº 239, de 3 de Novembro de 2021.

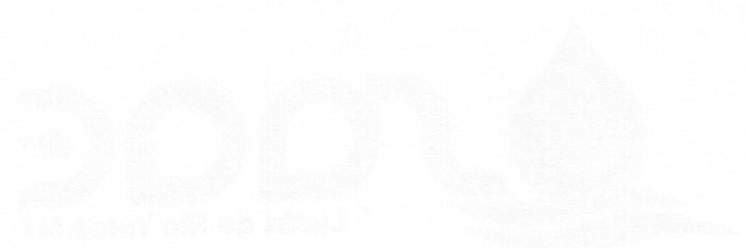
